RE: Drop Ship Services

TSW is pleased to provide Drop Ship Services for you and your customers.

In the United States, 46 states and the District of Columbia assess sales and use taxes of the sale of products to consumers and end users. All of these jurisdictions view drop ship sales as subject to sales and use taxes. In light of the June 21, 2018 Supreme Court decision in *South Dakota v Wayfair*, sales and use tax will now need to be collected and remitted on Sales made in the 46 states and the District of Columbia.

TSW is providing a Drop Ship Service for you; TSW is not the seller of record to your customer, and as such, TSW cannot collect or remit sales and use taxes, nor file the returns on your behalf. Accordingly, in order to continue drop shipments on your behalf, we are required to have you sign this letter, (a) acknowledging your Company's responsibility for the collection and remittance of sales and use taxes in all jurisdictions where required, (b) the provision of all documentary support, verifying the Company's compliance with these obligations, and (c) indemnification to TSW should the Company fail to meet these obligations.
